Investor-Platform Usage Terms

These Terms and Conditions (the "Agreement") govern the use of CrowdInvest <u>beta.crowdinvest.com</u>(the "Platform") for the investment in opportunities presented on the platform (the "Campaigns"). By investing in a Campaign, you ("you" or the "Investor") agree to be bound by these terms.

Definitions:

2. Investor Obligations

2.1 The Investor agrees to provide accurate and complete information when registering and investing through the Platform.

2.2 The Investor agrees not to engage in any fraudulent or illegal activities when using the Platform or investing in the Campaign.

2.3 The Investor agrees to comply with all applicable laws and regulations when using the Platform and investing in the Campaign.

2.4 The Investor hereby agrees not to participate in any form of communication or make investment offers to startups listed on CrowdInvest (<u>beta.crowdinvest.com</u>) outside the platform. The Investor acknowledges that engaging in such activities constitutes a material breach of this agreement, and as a consequence, legal action will be pursued against them.

2.5 The Investor agrees to maintain strict confidentiality of all sensitive or private information they gain access to on the platform. The Investor acknowledges that any failure to uphold this confidentiality constitutes a violation of intellectual property rights, and as a result, legal action will be taken against them

3. Platform Use

3.1 The Investor acknowledges and agrees that the Platform is provided on an "as is" and "as available" basis without any representations, warranties or guarantees of any kind, whether express or implied.

3.2 The Platform is not responsible for any loss or damage resulting from the use of the Platform, including but not limited to loss of investment, data, or profits.

3.3 The Investor agrees not to use the Platform for any commercial or non-personal purposes without the prior written consent of the Startup.

4. Governing Law and Jurisdiction

4.1 These Terms shall be governed by and construed in accordance with the laws of England and Wales and any disputes arising from or related to these Terms shall be subject to the exclusive jurisdiction of the courts of England and Wales.
